## ACRL OREGON CHAPTER FEBRUARY MEETING

The Oregon Chapter of ACRL and the Oregon Community College Library Association will hold a joint meeting on Friday, February 20, from 2 to 5 pm, at Linn-Benton Community College Library in Albany. The meeting will be in the Alsea-Calapooia Room of the College Center Building. You may park free in any campus parking area.

The topic of the meeting will be the Automation Study Committee report, which is scheduled to be completed February 14. The Automation Study Committee consists of five librarians appointed by the State Librarian and charged with preparing a report recommending guidelines for developing automation resource sharing in Oregon. John webb, the State Library representative on the Committee, will present the report. A panel discussion will follow. Panel members include Luella Pollock, Reed College Librarian and a member of the Study Committee; Jenko Lukac, a librarian from Lewis and Clark College who is also a member of the OLA Automation Committee; Jim Lockwood of the Oregon State System of Higher Education Library Council; and Sandra Blackaby, Treasure Valley Community College Librarian.

That evening, the community college librarians will be meeting at Mendel's Restaurant in Corvallis at 7 pm for dinner and a slide program on the Bahamas. The program will be presented by Joan White and Jack Henry, who are professional photographers and scuba divers. All ACRL librarians are invited to stay for the dinner and attend the evening program. The cost for the meal will be \$8.25 including gratuity. The next day, Saturday, February 21, the Oregon Community College Library Association will be meeting again at Linn-Benton. The program, which will run from 9 to noon, will provide an opportunity for members to share information about successful programs and procedures from their libraries. Again, ACRL librarians are welcome to attend.

# MOYNIHAN PROMISES FIGHT AGAINST "THOR RULING"

U.S. Senator Daniel Patrick Moynihan says he is planning to introduce new legislation in the 97th Congress that will address the substance of the IRS "Thor Ruling" —— presumably legislation that will exempt publishers. Under the ruling as it stands publishers can no longer discount their inventories for tax purposes. The resultant increase in taxes could amount to millions of dollars and have a severe impact on the size of future printings and the number of titles accepted for publication.

Replying to a letter sent by ACRL Oregon Chapter President Virginia Seiser, the New York senator said the Senate passed an amendment to an appropriations bill in December which would have prevented the IRS from implementing its ruling, but that the amendment was dropped by the House of Representatives.

Senator Mark Hatfield and Representative Denny Smith have also expressed varying degrees of concern and awareness in response to letters sent by Ms. Seiser.

It is strongly urged that ACRL members express their opinions on this issue to Oregon's Congressmen, Senator Moynihan, the Chair of the Senate Finance Committee (Washington, D.C. 20510), and the Chair of the House Ways and Means Committee (Washington, D.C. 20515).
