The eighth Annual Joint Washington/Oregon ACRL Conference will be held at the Black Lake Camp and Conference Center near Olympia, Washington, on October 15-16, 1987. The theme of this year's conference will be LEADERSHIP, CREATIVITY, AND MOTIVATION IN ACADEMIC LIBRARIES.

We are fortunate to have three highly qualified speakers for our conference this year. Our keynote speaker will be MARGARET E. CHISHOLM. Dr. Chisholm, Director of the University of Washington Graduate School of Library and Information Science, is currently serving as the President of the American Library Association. **She will speak on the role of leaders and leadership in academic libraries.** The first guest speaker will be JOANNE R. EUSTER. Ms. Euster, Director of Libraries for Rutgers University, is currently serving as the President of ACRL National. **She will speak about creative leadership in academic libraries.** The second guest speaker will be Ms. OLIVE C.R. JAMES, formerly of the Library of Congress. Ms. James is the new Library Director for San Francisco State University. **She will speak on the motivational issues of leadership.**

We have selected new facilities for this year's conference. The Black Lake Camp and Conference Center is situated on the shores of scenic Black Lake. The lodge and dining hall overlook the water. **The lodge houses no more than four people to a room, with each room having its own private bathroom with shower. You must provide all of your own linen, including sheets, pillowcases, sleeping bag, towels, washcloths, etc.** Smoking is not permitted in any of the buildings. The dining hall employs an excellent chef who will be taking care of our nutritional needs. There will be canoes and life jackets available for those who wish to explore the lake. Other recreational facilities include tennis courts, volleyball courts, horseshoes, shuffleboard, and hiking trails. Dress is casual and warm. **The traditional evening of socializing will feature the moving music of Kutumba, an African marimba ensemble from Seattle. Costumes are encouraged. The party will feature various non-alcoholic beverages.** NO ALCOHOL is allowed on the grounds. The telephone number for the Center is (206) 357-8425.

Check-in time is 12:00 to 1:15pm on Thursday. Late check-in will be between 5:00 and 6:00pm on Thursday. Check-out time is 1:00pm on Friday, just after lunch.

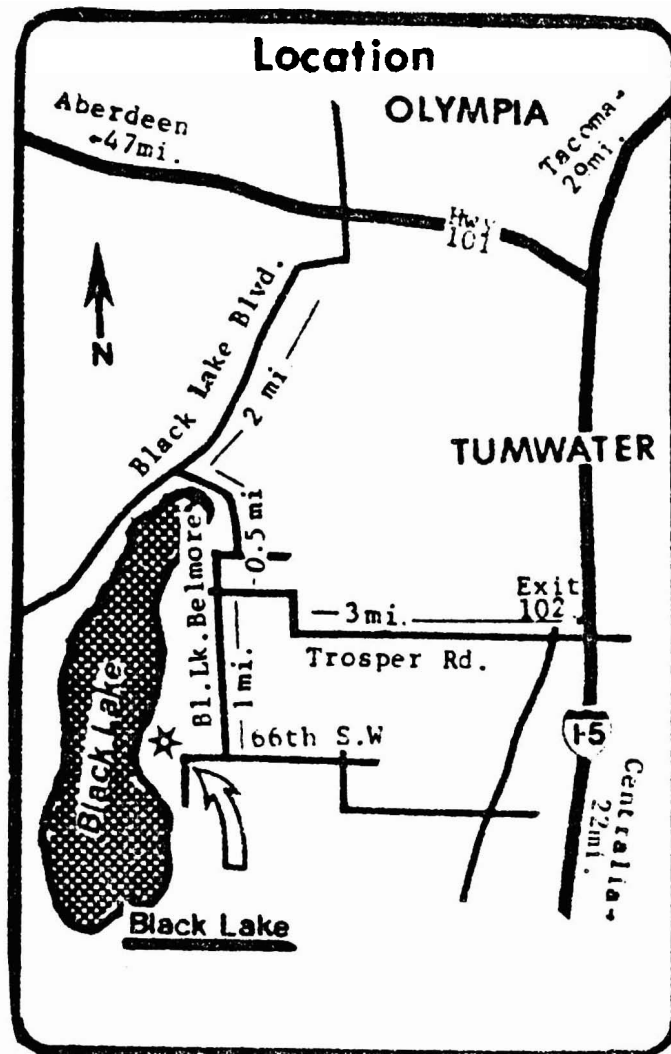

ACRL/OR CHAPTER ADVISORY BOARD MEETING HIGHLIGHTS

The ACRL/OR Advisory Board met on July 29, at Portland State University. Highlights from this meeting are as follows:

1. Nancy Powell, outgoing Chapter President, gave her last President's report, which included a summary of what was discussed at Chapters Council meeting at ALA in San Francisco. She recommended that each Board member be given a copy of the Guide to Policies and Procedures, detailing bylaws, rules, deadlines, procedures, and forms. She also indicated that the Oregon Chapter will again receive full funding for the CE course planned for next spring---one of seven chapters so funded in the U.S. National is highly in favor of what the Oregon Chapter is doing to provide improved access to continuing education in the State.
2. Alex Toth reported from the Nominations Committee, and presented the slate of candidates for Vice-President/President-Elect and for the two available Board positions. [See ballot and background information on these candidates given later in this issue.] Verl Anderson was appointed as the OSSHE representative to the Board and Wes Doak was appointed to continue as the State Library representative. [For background information on these individuals, see the section following these Board highlights.] No one, as yet, has been appointed to serve as Newsletter Editor for 1987/88.
3. The Fall Conference was discussed. Although this year's joint conference with the Washington Chapter is coordinated by Washington, two Oregon Chapter members will act as respondents on the panel. Michael Engle and Karyle Butcher will serve on the reactor panel.

IT IS IMPORTANT that as many Oregon Chapter members as possible attend the Business Meeting at the Conference in order to discuss and vote on a number of resolutions and issues which have come up including support for CLEP-O, the statewide resource sharing program, and the Oregon Coalition for Libraries. Election results will also be announced.

Plan to attend the Fall Conference and actively participate in keeping ACRL a strong organization. Note the Registration Deadline of October 2.

4. As noted in the previous Newsletter, the Continuing Library Education Project-Oregon (CLEP-O) needs your support. Letters of support, addressed to Wes Doak at the State Library and to your legislators, should stress the ongoing need for high quality continuing education opportunities in Oregon. LAMGO (Library and Media Groups of Oregon) suggests that funding should be provided from new state General Fund monies, not from LSCA or by shifting monies from other already-existing library programs. In your letters, it would also be helpful to note particular workshops offered through CLEP-O which you found especially enjoyable, informative, useful, and/or additional ones you would like to see offered in the future. In addition, at the Fall Conference Business Meeting, we shall discuss whether to put CLEP-O funding as a top legislative priority for the next biennium. [See also LAMGO article later in this issues of the Newsletter.]
5. The Advisory Board also discussed the 1988 OLA Conference, and it was decided that ACRL/OR would prefer to sponsor a lunch and a speaker at the spring conference if possible. Isabel Stirling, as our representative to the OLA Conference Program Planning Committee, will submit our request.

ADVISORY BOARD MEETING HIGHLIGHTS (CONT.)

6. The Board also ratified the appointment of Leslie Wykoff and Mel George as ACRL's representatives to the Oregon Coalition for Libraries' (OCL) Interim Board. Wykoff also presented an update on OCL's activities. [See articles on OCL, following in this issue of the Newsletter for further details.]
7. Michael Engle proposed a resolution to make support of the Statewide Resource Sharing Program the number one priority for library legislation in the 1989-91 biennium. The Board tabled a vote on this resolution until approval can be sought from the Oregon Chapter membership at the Fall Conference Business Meeting on October 15. [See related article, following the text of the PROPOSED resolution, later in this Newsletter.]

The next meeting of the Advisory Board will be held at the Fall Conference in October.

ACRL/OR CHAPTER ADVISORY BOARD APPOINTMENTS

The following individuals have been appointed or reappointed to the Advisory Board:

VERL A. ANDERSON - OSSHE Advisory Board Representative

Verl is Library Grant Director and Business Professor at Eastern Oregon State College and is a pioneer in Simultaneous Remote Searching. He received his doctorate in Business Administration from Arizona State University and his MLS and Bachelor's degrees from Brigham Young University. Verl has served as a consultant in online searching and SRS networking. He has published in Library Hi-Tech, Library Journal, and Rural Education Review.

WESLEY DOAK - State Library Advisory Board Representative

Wes is the Oregon State Librarian. Prior to coming to the State Library in 1983, he served as Chief of Library Development at the California State Library, Automation and New Media Consultant at the California State Library, and Principal Librarian at the Los Angeles Public Library. Wesley received his B.A. from Yankton College and his MLS from the University of Massachusetts. He was a Delegate to the White House Conference on Library and Information Services Task Force and currently serves on the Board of Directors for the Oregon Historical Society.

The appointed Board position of Newsletter Editor is still vacant. If you are interested in serving as Editor, contact Terry Soohoo (Portland State University) or Alex Toth (Pacific University) NOW!!

The Editor collects, edits, writes (sometimes), and lays out all copy for each Newsletter, which is distributed 4-5 times per year. This is a non-voting Board position, but attendance at Board meetings four times a year is encouraged. Librarians from central, eastern, and southern Oregon are encouraged to apply.

ACRL/OREGON ANNUAL ELECTIONS

A ballot is included in this issue of the Newsletter for the election of officers for 1987/88 and for new Advisory Board members. **Mail your ballot to ALEX TOTH, Pacific University Library, by September 30.** Results will be announced at the Fall Conference at Black Lake and in the next Newsletter. Information about the candidates and the selection process is included here.

OFFICERS: ACRL/Oregon has three officers - President, Vice-President/President-Elect, and Past President. Officers must be members of both Oregon and National ACRL, and candidates must be willing to attend the ALA annual and mid-winter meetings during their presidential year. Once elected, an officer serves three years, one each as Vice-President, President, and Past President.

ISABEL A. STIRLING. Head, Science Library, University of Oregon, 1982-date. Head, Bio-Agricultural Library, University of California, Riverside, 1979-82. Coordinator of Library Instruction for the Sciences, University of California, Riverside, 1977-79. MLS, Western Michigan University. Active in ACRL/Oregon Chapter; Member-at-Large, 1985-87. Active in ACRL nationally; ACRL-Bibliographic Instruction Section Policy and Planning Committee, 1984-88; ACRL-Science and Technology Section Oberly Awards Committee, 1984-85; ACRL Task Force on New Committee Members and Committee Chairs, 1984-86. Member of ALA, ACRL, SLA, ACS, OUG, and OLA. Active in SLA-Oregon Chapter. Professional interests include all aspects of science library management; library instruction; collection development; resource sharing; computer literature searching and training; and automation.

ADVISORY BOARD: The Advisory Board consists of eight members representing various types of academic libraries and geographic areas of Oregon. Four members representing community college, private college, OSSHE institutions, and the State Library, are appointed by the President. Four at-large members are elected by the Chapter membership. Terms are for two years, and half the Board membership changes annually. Each year the incoming President appoints two new members and the membership elects two at-large members.

SUE A. BURKHOLDER. Library Director at Southern Oregon State College. MALS, University of Missouri-Columbia; MA, University of Oregon; AB, Stanford University. She has recently edited Statistical Applications in Library Technical Services: An Annotated Bibliography. She is currently an Advisory Board member with the Pacific Northwest Conspectus Database.

KARYLE BUTCHER. Assistant Director for Research and Reference Services at Oregon State University Library. Prior to her coming to OSU, she administered the Support Services program at the Santa Barbara Public Library in California. In addition, she has served as the Chair of the Continuing Education Committee of the Oregon Library Association, and will be a panel member on the upcoming Oregon/Washington Chapters

BUTCHER (cont.). Joint Conference. MLS, University of Southern California; B.A., University of California at Berkeley. She is currently course work on a Master's degree from Oregon State University.

MICHAEL ENGLE. Reader Services Librarian at Linfield College. He was Reference Librarian at Willamette University from 1979-81. MLS, Western Michigan; BA, Denison University. Michael has served on the ACRL Advisory Board since 1985, and on OLA's Resource Sharing Committee since 1982. His special interests include course-related bibliographic instruction, and the relationships among philosophy, mythology, feminism, and college librarianship. He has published in the Journal of Academic Librarianship.

KAREN FISCHER. Director of Library and Media Services at Central Oregon Community College. She previously held a position in Reference/Cataloging at Montana State University Library from 1976-86. While in Montana, she served on several Montana State advisory committees, as President of the Montana Library Association from 1985-86, and helped to form the ACRL/Montana Chapter. MLS, University of Minnesota; MA (History), Montana State University. She has published articles in RQ, Choice, and Montana: The Magazine of Western History.

PROPOSED RESOLUTION--to be discussed--

The following resolution was drafted by Michael Engle, Linfield College, and will be discussed and voted on at the Fall Conference Business Meeting at Black Lake, on October 15. [See also Board Highlights on p. 6 of this issue.]

TO Wes Doak, Oregon State Librarian; Carolyn Peake, President of the Oregon Library Association; and June Knudson, Interim Chair of the Oregon Coalition for Libraries:

Be it hereby resolved, the ACRL/Oregon Advisory Board supports the Statewide Resource Sharing Program as the number one priority for library legislation in the 1989-91 biennium, and asks other Oregon library organizations to join us in a concerted effort to lobby the Legislature, the Governor, and the State Librarian to bring this proposal into law. As outlined in the Oregon State Library's 1987-89 budget request, the Resource Sharing Program includes support for the Oregon Database (adding support for ORULS, an important part of the database, with state funds), the Oregon Statewide Borrower's Card (including reimbursement for ILL net lenders), communications and delivery assistance (statewide courier system), the Pacific Northwest Conspectus Database, and a Last Copy Deposit Facility.

A STATEWIDE RESOURCE SHARING PROGRAM FOR OREGON: UPDATE

in a number of ways through the years, but the first attempt to fund an integrated package of resource sharing proposals surfaced in the Oregon State Library budget request for the 1985-87 biennium. Governor Atiyeh did not include the program in his budget request to the Legislature and the program died.

In early 1986, three members of OLA's Legislative and Library Development and Resource Sharing Committees worked as a joint subcommittee and crafted a position paper, "Library Resource Sharing in the State of Oregon." This paper was partly the outcome of discussions in the Resource Sharing Committee about the best way to find more financial support for the interlibrary services already in existence. The academic librarians on the Resource Sharing Committee were concerned about finding more funding for the large net interlibrary lenders and improving the speed of document delivery among libraries. The paper, using the \$1.2 million request in the 1985-87 State Library budget as a starting point, called for the development of an Oregon database which would include the holdings of all Oregon libraries, support for both interlibrary and direct borrowing, and improved communication and delivery among Oregon libraries using courier services, electronic mail, and telefacsimile.

Discussion in the Legislation and Library Development Committee and at the OLA Conference that spring added the idea of a statewide borrower's card; interlibrary loan reimbursement was absorbed as part of the cost of access to other libraries that the card represented. In September, 1986, the Legislative Package of OLA was approved at the annual membership meeting. Resolution #2 (of eight) endorsed the Oregon State Library operating budget AND PROPOSED INCREASES.

Among those increases was a five-part, \$4.4 million "Statewide Resource Sharing Program." PART ONE of the program, the Oregon Database (\$3 million), supported conversion of bibliographic records to machine-readable form--50¢ per new record input and up to \$1.34 for conversion of an existing record. PART TWO, the Oregon Statewide Borrower's Card (\$900,000), was "actually a euphemism for a method of reimbursing libraries for their costs in serving the users of other libraries," either by direct OR interlibrary loan. Interlibrary loans would have been reimbursed at \$2.46 each, direct loans at 46¢. PART THREE (\$400,000.), Communications and Delivery Assistance, would have funded a document delivery and telecommunications system, probably a contract courier plus some form of electronic mail. PART FOUR continued support for the Pacific Northwest Conspicuous Database (\$50,000.). The last item, PART FIVE, was \$100,000. for a "Last Copy" Deposit Facility. Again, the resource sharing increases proposed by the State Library were eliminated from the Governor's budget before it went to the Legislature.

In the meantime, however, librarians from all types of libraries were becoming more aware of and involved in the political process. OLA and the State Librarian have been working together to integrate support for legislative programs, a library political action committee has been established, and librarians have a lobbyist, Nan Heim, supported by OLA and OEMA.

This spring, after the Resource Sharing Program again failed to make the Governor's budget, OLA's Legislation and Library Development Committee decided to introduce a statewide library card bill. This bill, SB 735, brought the part of the Resource Sharing Plan thought most likely to succeed before the Legislature. Sen. Cliff Trow introduced the bill in the Senate Education Committee, where it was enthusiastically received, but it died in the Ways and Means Committee. The bill as written included only public libraries in the program, but OLA would have offered an amendment to include academic and other nonpublic libraries

libraries had it come to a vote. Meanwhile, some other library-supported legislation did pass, including \$11 million for library construction at Portland State University. Details of the Legislature's actions are available in Nan Heim's report to OLA/OEMA, summarized in the August issue of Oregon Library News.

Now, we are once again at the beginning of the legislative and political cycle; preparation for the 1989 legislative session and the 1989-91 state budget is already under way.

Because ACRL represents academic librarians in the Oregon library community, we need to be sure that the Resource Sharing Program and other library-related legislative proposals address the needs of academic libraries. Then, we must support those proposals in an organized way. Both issues up for discussion by the ACRL/Oregon Chapter membership at the Fall Conference at Black Lake, October 15, are important to our ability to have a positive effect on library-related legislation.

If we choose affiliation with the Oregon Coalition for Libraries, we will help support the library lobbying effort and have direct representation on the committee developing library legislation and legislative strategies. To be politically effective, we need to formally endorse the legislation we favor, and then work with other library organizations to pass and implement legislation supporting the development of Oregon libraries.

LAMGO NEWS

Paul Gregorio reported at the last Library and Media Groups of Oregon (LAMGO) meeting, held July 13, 1987, that the Continuing Library Education Project - Oregon (CLEP-O) had just completed its busiest quarter ever. 621 people attended the 19 workshops which were held this spring. He reported that many new faces were appearing at programs and that most of the attendees at the workshop entitled "Library Output Measures" were library directors.

LAMGO members have been meeting with representatives from other library groups to generate support to make CLEP-O a legislative priority throughout the Oregon library world. Jim Morgan, Chair of LAMGO, met with Sarah Long (Director of Multnomah County Library System) to exchange ideas. Joyce Petrie spoke with Gloria Withenbottom, who chairs the OEMA Legislative Committee.

Making CLEP-O a priority in the next biennium is one of LAMGO's goals, and they have asked the ACRL membership to discuss whether CLEP-O should be a **legislative priority**. At the **Fall Conference Business Meeting at Black Lake**, we will need to discuss this issue, and if we are willing to do so, develop a formal resolution. ATTEND THE ACRL/OR CHAPTER BUSINESS MEETING ON OCT. 15!!!

WHAT IS THE OREGON COALITION FOR LIBRARIES??

History. Since 1985, associations representing various kinds of libraries in Oregon have been discussing ways in which our groups can best cooperate to improve services to all Oregon libraries. Representatives of Oregon Library Association (OLA), Oregon Educational Media Association (OEMA), Association of College and Research Libraries/Oregon Chapter (ACRL/OR), Special Libraries Association/Oregon Chapter (SLA/OR), and the Oregon Health Sciences Libraries Association (OHSLA) have been exploring the benefits of forming an organization consisting of librarians from these different kinds of libraries.

Purpose. The purpose of the Oregon Coalition for Libraries (OCL) is to form a cohesive organization of library associations in Oregon which would allow existing associations to preserve their missions and purposes while forming a strong and unified library presence in Oregon. This strong presence will increase our visibility and credibility with decision-makers. Greater cooperation and communication will improve services in all Oregon libraries.

Current Status. The efforts described above have resulted in the Oregon Coalition for Libraries, with a Board including representatives from all the organizations listed above. In July, 1987, this Board drafted a set of Interim Bylaws for the Coalition to use during a two-year trial period. These Bylaws were sent to the Boards of Directors of each individual association for approval. When a Board approves the Interim Bylaws, members of that association are then members of OCL, and that association is entitled to send representatives to the OCL Board meeting. The future of the Coalition will be decided by participating organizations in October, 1989.

Activities. Using a list of priorities prepared by each organization's representatives, the OCL Board proposed the following activities for 1988:

- **CONTINUING EDUCATION (work to gain permanent funding for Continuing Library Education Project-Oregon (CLEP-O); continue to offer additional continuing education opportunities)
- **PLANNING FOR an October, 1989, JOINT CONFERENCE in Seaside
- **LEGISLATIVE (combine legislative committees and lobby the Governor's Office)
- **INTELLECTUAL FREEDOM (combine committees and coordinate with the Oregon State Library Intellectual Freedom Clearinghouse) [see p.7 of the June, 1987, issue of this Newsletter for information on the Clearinghouse---Editor's note.]
- **PUBLICATIONS (OCL insert to be added to groups' existing publications, to inform members of library activities of other organizations)
- **PROMOTION (explain OCL's purpose to members via publications and a series of statewide presentations, and to hear members' ideas and concerns)

Summary. During the two-year trial period, the Coalition will provide a forum for cooperation and communication, to help us work together for the improvement of services in all Oregon libraries.

MORE ON THE OREGON COALITION FOR LIBRARIES

From Leslie Wykoff, ACRL Advisory Board Member-at-Large.....

Do you remember that April, 1987, special issue of a newsletter called THE OREGON COALITION FOR LIBRARIES? You should have received it as an ACRL/OR Chapter member. On the front page of that publication was a chronology of the OCL by Lynn Chmelir, who, at that time, was one of ACRL's representatives to the OCL Task Force. If you saved that special OCL publication, grab it and read that chronology again because this is the next installment.

The member groups of OCL (which are OLA, OEMA, OHSLA, Oregon Chapters of SLA and ACRL) reviewed the draft of the proposed OCL Bylaws. As a result of their feedback, the proposed OCL Interim Bylaws were rewritten by the OCL Task Force and copies of these will be available at the Fall Conference Business Meeting in October.

In addition to rewriting the Interim Bylaws, the OCL Task Force, when it met this summer, was consistent with the representation suggested in the new Interim Bylaws. The Task Force prepared the RESOLUTION which each member group will need to discuss and sign in order to formally join the OCL. [See above.]

The Task Force also prepared the OCL Services and Activities for 1988 [see p.11 of this Newsletter] and a proposed budget. Startup costs were estimated at approximately \$2,400./year, plus \$12,000./year for a lobbyist. The budget will be raised by dues paid by individual members of the five participating organizations. [Editor's note: Proposed dues would be \$12/member/year, an increase for ACRL/OR members. In addition, approximately 49% of ACRL members are also OLA members. These individuals would pay only one \$12. fee.]

OCL (CONT.)

The OCL Task Force also decided to plan an OCL Annual Conference for the fall of 1989. (Isabel Stirling is ACRL's appointed representative to the Conference Planning Committee.) In addition, the OCL Task Force members committed themselves to explaining the OCL concept to groups of librarians throughout the State. LETTERS TO CONGRESS NEEDED IMMEDIATELY

How to get HEA II-A and II-D funded.....

With the active involvement of ACRL, ALA recommendations for Title II library programs were accepted by Congress in the Higher Education Act Amendments signed into law last October. This was a major accomplishment; it puts the basic law for these programs on the books for five more years. But the appropriations of actual funds for each program is a whole separate process. It must be repeated every year, since Congress funds programs for only one year at a time.

To complete the job ACRL began in the reauthorization process, your help is needed to persuade Congress to fund HEA II-A (college library resource grants) and II-D (college library technology grants) for FY 1988. Take the time to

write to Senator Mark O. Hatfield, Senate Labor-HHS-Education Appropriations Subcommittee, Washington, D.C., 20510

In Congress' deficit reduction climate, II-A and II-D won't be given consideration UNLESS there is a ground swell of support for funding, and a congressional champion is developed on the appropriations subcommittees which handle library programs. PLEASE WRITE, and urge at least three colleagues in your area to respond as well. It WILL make a difference. LSCA II construction funding was restored in FY 1983 after ten years of no funding; the new LSCA VI literacy was funded for the first time in FY 1986. Why? Constituent pressure on a key legislator!

NORTHUP LIBRARY celebrated fifty years of service to Linfield College with a birthday party last May. It was held in conjunction with Alumni Weekend and many members of the class of 1937 attended. One person remembered sleeping on the front porch for two nights to guard the books because the doors had not yet been installed.
