OREGON STATE LIBRARY ANNOUNCES MEETING SCHEDULE FOR 1988

September 23, 1988

The State Library Board of Trustees will meet at 10 a.m. in the State Library Board Room, Salem, Oregon.

The Board will hear reports from the State Librarian and staff on EDNET, Library of America, Northwest Group Access Project, Banned Books Week, Untaxed/Unserved populations and the current status of OPAC and Board goals for the biennium.

Issues for consideration will include the State Library's Affirmative Action Plan and a review of Administrative Rules for the Library.

September 26, 1988

The Oregon State Library Foundation will meet at 10 a.m. to review programs and elect officers.

November 4, 1988

The State Advisory Council on Libraries will meet at 10 a.m. to review project proposals for Library Services and Construction Act grants for FY 1990. The Council will also hear reports on recent activities at the State Library, on the status of Federal funding for libraries, and on the progress of LSCA grant projects funded in the current fiscal year.

December 9, 1988

The State Library Board will meet at 10 a.m. to review LSCA grant applications and recommendations of the State Advisory Council; discuss progress on meeting Board goals for the biennium; hear a report on OPAC status; and plan for the coming Legislative Session.

Unless otherwise stated, all meetings will be in the State Library Board Room (Room 14, State Library) in Salem. Interested persons are invited to attend these meetings and participate in the Open Forum usually scheduled for 11:30 a.m.

Minutes of Advisory Board Meeting
June 24, 1988
University of Oregon Library

The meeting was called to order by President Terry Soohoo and the minutes of the April 7, 1988, Board meeting were approved.

Terry reported that OCL asked us to send a list of our committee chairs. The Board agreed to a preliminary inquiry from ACRL National to do a poster session at a professional development jamboree next April in Cincinnati. Our Menucha meetings are a likely subject.

Isabel reported that the treasury and membership are essentially unchanged since the last report. There was some discussion about how to handle the ACRL CE grant since OLA handled all the billing and kept all the profits from activities at the OLA Annual Conference last April. Isabel announced that she has appointed Nadine Miller to the private college position on the Board, replacing Alex Toth, and Karyle Butcher to the OSSHE position, replacing Verl Anderson. Maureen Sloan is the Nominating Committee's selection for Vice President/President-Elect. Nominees have not yet been selected for the two at-large positions.

Linda Cochrane's OLA report was circulated; there was no LAMGO report.

Terry announced that Kathleen Heim and Jay Martin Poole will be the speakers at Menucha this fall. ACRL will pay their airfare and room. Terry is writing for foundation and vendor support for Menucha and has asked for \$1000 from ACRL National.

The Menucha schedule was finalized. The Oregon Chapter Board meeting was inserted (sic) at 7:15 pm Thursday, and the Recorder was encouraged to attend. Several Board members volunteered to be small group leaders.

The Board set a discussion of whether the Oregon Chapter should become the Academic Library Section of OLA for the membership meeting at Menucha. The Board then discussed some of the financial and organizational implications of moving into OLA. A major concern is control of profits from Menucha and from ACRL CE workshops.

Isabel Stirling agreed to be the speaker at the 1989 Academic Breakfast at OLA; she will regale us with stories from her forthcoming experiences as an ALA Book Fellow in Turkey this fall and winter.

Board members attending: Pres. Terry Soohoo, V. Pres. Isabel Stirling, Recorder Michael Engle, Newsletter Editor Karyle Butcher, Sue Burkholder, Maureen Sloan, and Leslie Wykoff.

RESOLUTION TO JOIN OLA

In the previous newsletter it was discussed that OLA has encouraged ACRL/OR to form a new Academic Librarians Division of OLA> On December 9, 1987 OLA passed a motion supporting a strong and unified library organization and inviting our group to join a restructured organization modeled after ALA.

In February, 1988 Carolyn Peake, then President of OLA, wrote to invite us to join OLA as a division. Lynn Chmelir, current President of OLA, then came to speak before the ACRL advisory Board in April to discuss this possibility. She stated that "OLA's invitation was open and continuing and has been extended to all library organizations participating in the Oregon Coalition of Libraries discussions."

For some members who do not currently belong to OLA, this action would result in a dues increase. Only 50% of chapter members belong to OLA, and as members of a division, people would have to pay OLA dues. Lynn Chmelir has mentioned the possibility of a three year phase-in for increased dues.

The Advisory Board has discussed this matter as a group and with many members of ACRL/OR and wishes to bring the matter to a vote of the membership at the general chapter business meeting this October at the Menucha conference. Members will be asked to vote on the resolution given below.

WHEREAS,

There exists substantial support for a cohesive library community in Oregon, and

WHEREAS,

The Oregon Library Association has extended the invitation to ACRL/OR to form an Academic Librarians Division of OLA, and

WHEREAS,

The national ACRL has discussed and expressed the need for affiliations between chapters and state library organizations, and

WHEREAS,

A number of academic library organizations in other states are organized in this manner, and

WHEREAS,

An Academic Librarians Division of OLA can remain a chapter affiliate of ACRL,

THEREFORE BE IT RESOLVED

That the membership of the Association of College and Research Libraries, Oregon Chapter, directs the Advisory Board of the Chapter to negotiate with OLA concerning a phased-in dues structure, independent fall conference budget, and other organizational matters, and if such matters can be satisfactorily resolved, that ACRL/OR become the Academic Librarians Division of ACRL.

The next meeting was scheduled for Sept 17, Salem Public Library.


NEWS FROM UNIVERSITY OF OREGON

UNIVERSITY LIBRARY NAMED IN HONOR OF KNIGHT FAMILY

The University of Oregon Main Library has been named the Knight Library for the family of co-founder of NIKE International, Inc., UO alumnus Philip H. Knight. The opportunity to name the building is the result of a very significant gift to the University to support the Library expansion and renovation. The complete Library renovation and expansion totals \$25.7 million and will add 160,000 square feet to the existing facility.

LIBRARY NAMES JUVENILE COLLECTION

The University Library has named its collection of juvenile literature as the result of a bequest left to the University by Mildred M. McKnight, formerly of Lebanon, Oregon. The McKnight Juvenile Collection includes approximately 14,000 volumes of children's and young adult literature (fiction and non-fiction), children's periodicals, and reference books. The collection supports the research and instruction of teachers of children pre-kindergarten through grade 12 and is located in the Knight Library building.

NINTH ANNUAL JOINT FALL CONFERENCE
ACRL/OREGON AND WASHINGTON CHAPTERS

The annual joint conference of the Oregon and Washington chapters of ACRL will be held October 27-28, 1988 at Menucha Retreat and Conference Center.

This year's conference theme is "Scholarship for Academic Librarians." Two main speakers will be featured. Kathleen Heim, Dean of the School of Library and Information Science, Louisiana State University at Baton Rouge and editor of RQ and Journal of the ALA RASD will speak on Thursday. Jay Poole, Assistant University Librarian from the University of California at Irvine and former editor of Choice and of the Texas Library Journal will speak on Friday. The two will give presentations and lead small group sessions. Several academic librarians, including Nancy Powell, Kris Rankka, and Karyle Butcher from OSU, Michael Engle of Linfield College, Janet Wright from Portland State, Kay Vyhnaneck and Janet Chisham from Washington State University, and four other librarians from Washington will serve as small group leaders. Topics for groups include Identifying What is Unique in Our Work and Developing Ideas, Paper Publication, Scholarship in the Community College Setting, Forming a Writers Group, How to do a Poster Session, and Where Do I Find the Time?

A registration form appears in this newsletter. Conference registration deadline is October 5 if you wish the best rates. We have been able to hold conference costs to the same amount as they were in 1986 through the generous assistance of the Rose E. Tucker Charitable Trust, the S. S. Johnson Foundation, Academic Book Center, and several other vendors.
