### PRESIDENT'S MESSAGE

It was good to see so many of you at the OLA Conference. We feel that the ACRL sponsored programs at the conference were most successful and we hope to do as well next year. If you have program ideas you should contact Sara Brownmiller at 346-3047; she will be ACRL's liaison to the 1991 OLA Conference Program chair. There are two ACRL sponsored preconferences at the PNLA conference in Portland; look for registration information in this issue.

The ACRL board has worked very hard this year to become more knowledgeable and active on legislative issues. Through our representatives on the OLA Legislative Committee and through attendance of academic librarians at the OLA sponsored regional legislative meetings, we succeeded in bringing academic concerns to the attention of OLA. Resource sharing is one of the top priorities in OLA's legislative package: this item will ensure the continuance of ORULS and provide funding for net lender reimbursement. The next phase of legislative action - trying to get funding for the State Library budget, which will include OLA's priorities - is very difficult, and requires lobbying of legislators by OLA (and ACRL members). Nan Heim, OLA's lobbyist, is urging librarians to work on legislative or gubernatorial campaigns and let it be known that you are interested in increased State funding for libraries. If you are working on a campaign please let me know; OLA will send you information on library issues which you can try to bring to your candidate's attention. It is felt, by those who know, that both the major candidates for Governor are likely to be sympathetic to libraries.

It is the time of year when we are seeking nominations for President-Elect of ACRL/Oregon and for members of the Advisory Board. If you are interested in serving or wish to suggest a person for nomination, please call Leslie Wykoff, who is chair of the Nominating Committee at 494-8026.

Planning for the Menucha conference is continuing, and you will find more information in this issue of you newsletter.

# Minutes of Advisory Board Meeting March 29, 1990 OLA Conference Portland, Oregon

The meeting was called to order by Maureen Sloan. Minutes from the Feb. 1, 1990 meeting in Eugene were approved.

Karyle Butcher gave a report on membership. She has received the OLA membership list from Marie Mulholland. There are apparently 160 academic librarians on the list who are not now ACRL members. In the future we might want to put together a directory of Oregon's academic librarians.

Maureen gave a conference update. Maureen Sullivan has arrived and her Friday program is set as is the CD-ROM panel. Deborah Fetch reported that the Technical Services program with Louise Saylor was very well received, and there was standing room only.

Sue Burkholder reported on the recent regional Legislative Meetings around the state which provided a forum to discuss the legislative agenda. These were well attended in Southern Oregon. The end product of these meetings was in the handout presented at the General Session Membership Meeting this morning. There was discussion as to how the list had become prioritized as it was our understanding that this was not going to happen. While LSCA is listed as #1 this is still a total package and all items need to pass. Maureen attended the last OLA Board meeting and indicated they are looking for a catchy phrase that will sell the whole package; she suggested "75 cents for Libraries". There was some concern that OLA's priorities are not necessarily the State Library's priorities. Questions were raised as to how we get support for our priorities from legislators; how do we get them into the Governor's budget; who moves OLA Legislative Package through the budget process? Carol Dickerson, Chair of the Legislative Network, is working on a press kit to be available during National Library Week. Maureen will ask her to the next board meeting to discuss ways that ACRL might help.

Maureen brought us up to date Menucha. Vendors need to be contacted and our speakers still need to confirm in writing. Karyle suggested the theme for the conference which eventually evolved into "Diversity: Why We Should Care; What We Can Do".

Sue Burkholder is Conference Chair for the 1991 OLA Conference which will be held in Ashland. Teri Rohe is the Program Chair. We will need to decide what programs we want to present, and submit them by early fall. Next meeting we will discuss both Menucha and OLA in more depth.

Maureen discussed the 1991 White House Conference and what input

ACRL might have. The Oregon White House Conference Planning Taskforce will be holding local and regional "speak-out" meetings to develop issues prior to the conference. The OLA Vision 2000 Committee was appointed to develop a long range plan for the improvement of all Oregon libraries. This committee has requested "vision statements" or position papers from interested libraries and library groups. These vision statements will be available at the various "speak-outs" and may be a more appropriate way for academic libraries to express their views. What libraries or library groups would be willing to write a position paper--OSHI, NAPCU, Community Colleges, DIGOR? The question was raised as to whether the ACRL Board should do one on resource sharing. Maureen appointed a subcommittee to work on this including Eva Calcagno and Karyle Butcher, and possibly Michael Engle as a third member. Maureen also distributed a first draft of a letter regarding the White House Conference that could be disseminated through newsletters to academic library users such as AAUW. This matter was tabled for the present.

Deborah raised the question of the future of the ACRL Newsletter. Should we maintain the same format, how many issues per year, or should we incorporate with the OLA Newsletter? The next issue of the newsletter comes out at the end of June and will include information on Menucha. It was agreed that a full discussion of the Newsletter would occur at a later Board meeting this fall. For the next meeting, however, we can all bring items of interest for Deborah such as staff changes, etc.

The State Library Board is meeting this Saturday. Michael Engle has written a letter for NAPCU in support of resource sharing which states in part that this is not now being adequately addressed. Maureen will also write a letter from ACRL.

The Oregon State Library announces the following meeting and major event schedule for the summer of 1990.

July 16, 1990

The Oregon State Library Board of Trustees will meet at the State Library from 10 a.m. to 4 p.m. to finalize the State Library budget request. The Board will also discuss progress of the Board's biennial goals.

#### August 16-18, 1990

Oregon will send delegates to a meeting in Nashville, Tennessee, to discuss and plan for the 1991 White House Conference on Library and Information Services. Delegates will include lay people and professional librarians. The delegates are: Larry Dalrymple, Jolinda Osborne, Anne Carter, Jim Hayden, George Happ, and Ronnie Budge. This Program is funded with a special grant from the National Commission on Libraries and Information Services.



"PNLA: On the Pacific Rim, "--This year's Pacific Northwest Library Association Conference theme has a special ring in these times of changing economic and political realities. The Portland conference, August 15-18, will offer many opportunities to explore what it means to deliver library services in this strategically located part of the world at a significant moment in history.

Keynote speaker Robert A. Kapp will set the tone on Wednesday evening with his address, "The Pacific Rim: Fact and Fancy, Use and Misuse." Dr. Kapp, an East Asian scholar who has lived in Taiwan and Japan, is currently President of the Washington Council on International Trade.

Bette Tonglao of Seattle Public Library and Jim Takita of Multnomah County Library will offer "Resources for Information on the Pacific Rim," on Thursday morning. The program will cover resources for information about the culture, politics, and economy of the Pacific Rim nations.

Workshops on Pacific Rim consortia in the Northwest and on the significance of Pacific Rim development to the management of library collections will be offered on Thursday afternoon and Friday morning, respectively.

The Friday exhibitor's luncheon will feature "The Russian Connection." President Carol Hildebrand has invited two librarians from Irkutsk, Siberia, to speak at the luncheon. Glasnost and good fortune prevailing, they will arrive as planned.

Maxine Hong Kingston, author of THE WOMAN WARRIOR, CHINA MEN, and TRIPMASTER MONKEY--HIS FAKE BOOK, is featured speaker at Friday evening's banquet. Ms. Kingston, numbers among her honors the National Book Critics Circle Award (1977) and the National Book Award (1981). Her work examines the experience of being a Chinese American, raised in a Western country and culture yet retaining a psyche imprinted by an Eastern heritage.

In addition to the special theme programs, conference attendees will find workshops and events to suit every interest area of specialization.

Wednesday offers three preconferences. "Improving Your Teaching Skills," features Trish Ridgeway, Coordinator of Bibliographic Instruction at the University of Pennsylvania's Van Pelt Library. Sponsored by ACRL, the workshop will develop and improve teaching skills for bibliographic instruction, staff development, and other educational opportunities. Charlaine Ezell of Ezell communications and Presentations will offer "CE = MC2: Adult Learning and Training." This preconference covers adult learning and training methodologies. Ms. Ezell will also offer "Accidental Tourist: Futuring Techniques," on Thursday morning and "Mind over Matter: Creative Problem Solving," on Thursday afternoon.

A third preconference, "Principles and Practices for Quality Collections on Behalf of Children and Young Adults," will be lead by Mary Bushing, Collection Development Officer at Montana State University. The workshop offers collection development and assessment techniques for school media centers and public libraries.

Other programs offerings include everything from "Understanding Folk Literature" to "Competitive Intelligence" and "Strategic Planning" to "Out-of-Print Buying." Along the way you'll find workshops on customer service and the aesthetics and functionality of library buildings, along with discussions of faculty status, cataloging concerns and the relationship among library directors, friends, and trustees. Developers of local history and archival collections and librarians who long to be published will also find their niche.

Several featured speakers are scheduled for conference meal events. Louis Sachar, author of the 1990 Young Reader's Choice Award winner, THERE'S A BOY IN THE GIRLS' BATHROOM, will speak at the YRCA luncheon on Thursday. Ginnie Cooper, newly appointed Director of the Multnomah County Library, will address the Trustees' Breakfast on Saturday morning, commenting on the future of the public library and her plans for the MCL.

Those in need of refreshment on Thursday afternoon can join Cans Across the Border for Fred Eckhardt's talk on "Microbreweries: The Brew Pub Movement in Oregon." A field trip to a local brew pub will follow.

The program includes a number of very special events not to be missed. Prior to Wednesday's keynote, Powell's Books will host a reception in their newly expanded main store. The reception will be preceded by a walking tour of other downtown Portland bookstores.

The Thursday evening dinner cruise aboard the sternwheeler Columbia Gorge will be a conference highlight. Be sure to purchase tickets early, as space is limited. Chartered bus transportation to the start of the cruise in Cascade Locks and back to the conference hotel will be provided.

# ACRL OREGON - WASHINGTON CHAPTERS JOINT FALL CONFERENCE AT MENUCHA

The joint Fall conference of the Oregon and Washington Chapters of ACRL will be held on October 25th and 26th 1990 at Menucha Retreat Center in the Columbia Gorge. The conference theme this year will be "Diversity; why we should care and what we can do". Our speakers will address the theme of cultural diversity, but in small group discussions we hope to broaden the issue to include other types of diversity.

The speakers for the conference will be Vivian Sykes, Multicultural Reference Librarian at the University of California, Santa Cruz, and Janice Kido, a consultant on cross-cultural communication and multicultural education. Janice Kido who is from the University of Hawaii at Manoa is presently a visiting faculty member at the Evergreen State College and is working with colleges in the region to support faculty development in coping with diversity. Vivian Sykes' talk will be titled "Two Roads Diverged" and will address the issues of cultural diversity and their implications for academic librarians; she will discuss the work being done in the UC system on cultural diversity and its impact on their libraries. Janice Kido will talk on managing staff and student diversity and on cross-cultural ways of knowing.

The Oregon Library Association's VISION 2000 COMMITTEE (previously called the Long Range Planning Committee) is charged with developing long range goals for the improvement of all Oregon Libraries. The committee is asking Oregon library organizations and OLA Committees to contribute "vision statements" outlining specific directions for Oregon library development in the 1990's.

The VISION 2000 COMMITTEE will compile the statements into a document to be printed and disseminated. It will hopefully become a focus for comment and discussion at meetings throughout the rest of 1990. It is expected that the "vision statements" will become a major focus for the Oregon White House Conference local and regional "speak-out" meetings planned prior to the 1991 conference.

A final document entitled VISION 2000 will be produced by the committee based on the outcome of these various meetings. They will then ask that it be formally accepted and adopted by all major library organizations in the state and by the Oregon State Library Board of Trustees early in 1991.

Oregon's steering committee for the White House Conference on Library and Information Services is announcing local SPEAK UP FOR LIBRARIES meetings as their 1990 preconference activity. After soliciting input from organizations and individuals and because of Oregon's geographic diversity, the committee felt that in order to have a true statewide program, <u>community-based town meetings</u> should be held rather than a single conference in Salem.

Holding a SPEAK UP FOR LIBRARIES meeting in your community can <u>stimulate</u> interest in and support for your library, <u>identify</u> library issues important to Oregonians, and <u>assist</u> in the delegate selection process. An added benefit of holding such meetings is <u>good public relations for local</u> <u>libraries!</u> The national goals of the White House Conference include identifying ways libraries can be improved to strengthen democracy, expand literacy, and increase productivity. In Oregon, our statewide goals are to discuss such proposals as OLA's **Vision 2000** statements and to obtain views from individual citizens. From delegates nominated at local SPEAK UP meetings, eight individuals (two lay, two library, two government, and two trustees/friends) will be selected to attend the Washington, D.C. White House Conference in July 1991.

Attached is an application form to be completed and returned to the Oregon Library Foundation by July 1, 1990. For those applications that are approved, we will provide a stipend of not more than \$100 and a workbook, including press and organizational materials. Community SPEAK UP meetings would be held in September through November, and the minutes and delegate nominations are due in the Foundation office on January 1, 1991.

# PORTLAND STATE UNIVERSITY

The government documents division of the OSU Library has been chosen by the federal government as a test site for evaluating the feasibility of electronic dissemination of information to depository libraries.

Data available includes information from the International Trade Administration, Bureau of Economic Analysis, Census Bureau, Bureau of Labor Statistics, Federal Reserve Board, etc. Examples of information available through the Economic Bulletin Board(EBB) are the Consumer Price Index, Gross National Product, employment statistics, and daily trade opportunities for exporters.

Many widely used statistics, such as the CPI, are loaded onto the Bulletin Board within 15 minutes of their official release. Twothirds of the files on the EBB are updated on a quarterly or monthly basis. Selected information may be updated daily.



#### ATOMIC ENERGY COLLECTION

Oregon State University recently purchased the Atomic Energy Collection from Leif Laudamus, a collector and dealer of rare books. Clifford Mead, Special Collections Librarian, describes the acquisition as one of the more important research collections on the subject in the United States. The collection consists of nearly 3,000 items, including the first published account of the discovery of radioactivity in 1896 by Nobel Prize winning Henri Becquerel, writings on the Manhattan Project, the hearings of Robert Oppenheimer, and formerly secret reports of the effects of the atom bomb.

NEW DOCUMENT DELIVERY SERVICE OFFERED AT OSU

The OSU Libraries have begun a pilot document delivery/journal table of contents service with several on-campus departments and two OSU Extension offices located off campus. The Library photocopies tables of contents of selected journal titles as each new issue is received in the library; photocopies are then Faculty members mark forwarded to appropriate departments. articles they wish to have copied for them and send this information back to the library, which fills their requests. The library also accepts requests for copies of older journal articles. As a pilot project, faculty are being charged only photocopy costs (\$.10 per page). Other costs will be determined later in the summer and the library will charge accordingly for the service thereafter.
