# MEASURE 9 AND OREGON LIBRARIANS

**Guest Editorial** 

Why are the Oregon AND American Library Associations so concerned about Measure 9? Why have the Intellectual Freedom Committee and the Social Responsibility Round Table (SRRT) joined forces in an effort to educate as many people as possible about dangers on this divisive measure?

If Measure 9 is really as innocuous and straight forward as its sponsor, the Oregon Citizen's Alliance (OCA) would have us believe, would family members and friends from as far away as Texas and Ohio have heard about an Oregon ballot measure? These friends weren't sure of the exact wording of Measure 9, but they had heard of the discriminatory nature of this amendment to the Oregon Constitution and wrote or phoned to askif I thought Oregonians would really pass such a law. Would we? I don't know.

SRRT hopes that education about its dangers will prevent our making such a mistake. Aside from the emotional tax on so many of us, what does Measure 9 mean to librarians? The far reaching censorship

implications spring to mind immediately. For instance, do we interpret the objection to facilitate or promote anything positive about homosexuals to mean that not only famous books ABOUT homosexuals but also by gay authors have to be banned from our libraries? Some believe so, all of which will be very costly in money and time.

Portland judge Kathryn English in a speech warned that passage of Measure 9 would open the door to a wide variety of interpretations by lawyers and judges because even the courts are unsure and divided about the exact legal meaning of the wording of this measure. Challenges may take years and millions of dollars to resolve.

Insurance companies, fearing the loss of millions in legal awards, may drop insurance policies for cities and towns, as happened in Springfield for a period of about three weeks immediately after a similar measure passed in that city.

Can Oregon afford a witch hunt that will cost additional millions in lost revenues from cancelled conventions or business deals by people unwilling to choose Oregon with its repressive climate? Librarians have a particularly strong sense of people's inalienable rights to equal access to information and services, and SRRT doesn't doubt that we will not support Measure 9 as professionals. However, SRRT hopes that librarians will go a step further and actively work, in their own time, toward defeating Measure 9. We must oppose ALL discrimination or our rights will disappear one-by-one.
