1. Call to order

3. OLA EDI Task Force

- Alma Plasencia and Marci Ramiro-Jenkins, co-chairs of the OLA EDI Anti-Racism Special Committee, introduced and gave an overview of a draft of the committee's Equity Diversity Inclusion Anti-Racism Toolkit. The toolkit will be finalized in late January and then disseminated to public and academic libraries in February.
- Halsted Bernard shared via Google Docs a statement about EDI and Anti-Racism for PLD board members to edit or add to.
- Print copies going to public and academic libraries, with hopes that school libraries will access and use an online version of the toolkit.
- The committee is encouraging as many libraries as possible to have their staff members complete, by early March, the survey included in the toolkit
- The toolkit, and findings from the staff-survey instrument, will be discussed at a pre-conference session at the 2021 OLA Conference (April 20-23)
- Kate Lasky asked if there were any self-assessments that the committee would recommend for staff members, board members, and city council members to use to ascertain their own place on the continuum of readiness.

4. OLA Strategic Plan Input

- Kate Lasky presented a draft of the strategic plan, and asked us to note areas where PLD can be a responsible party for initiatives or supporting actions, or is already taking actions to meet various objectives or targets.

9. Oregon Digital Library Consortium (ODLC) Update

Elizabeth Sonstegaard (Albany Public Library), vice-chair of the Oregon Digital Library Consortium, provided the following report:

- Got some additional LSTA funds, earmarked for Spanish-language materials.
 Continuing to add Spanish-language materials, and also have a Spanish-language page in Overdrive.
- Considering free program called Public Library Connection, which would connect some school libraries to ODLC, allowing students to access juvenile and youngadult materials.
- In January ODLC will pass 1-million+ checkouts.
- Budget season is here, and governing board is creating poll to see where member libraries are on budget planning and priorities.
- We have been seeing usage up over 25% the last six months, holding steady.

10. State Library of Oregon Update

Darci Hanning, the board's rep from the State Library of Oregon, submitted the following report in absentium:

- Draft applications for LSTA competitive grants were due on 12/4 (optional) and final applications are due February 1, 2021, 5:00pm PT. Please see the <u>LSTA LibGuide</u> for more information.
- Ready to Read checks for 2021 are in the process of being sent out; follow-up with Greta Bergquist if you have any questions or concerns.
- Review for <u>minimum conditions for public libraries</u> will begin next year; data collected from the annual Public Library Statistical Report will be used. If you have any questions or concerns, please contact Darci Hanning.
