ACRL/OR CHAPTER ADVISORY BOARD MEETING HIGHLIGHTS

The ACRL/OR Board met on April 23, at the joint Oregon Library Association/ Washington Library Association Conference in Portland. Highlights from this meeting are as follows:

- During the OLA/WLA Conference, ACRL/OR sponsored a <u>breakfast for academic</u> <u>librarians</u>, on April 24, at the Red Lion Inn in Vancouver. Maureen Pastine, Director of Libraries, Washington State University, discussed her experiences as a tour leader of librarians to China, Australia, and New Zealand. Approximately 50 people attended her slide presentation, which included a buffet breakfast. Maureen Seaman and Terry Soohoo handled registration and arrangements---thanks for your hard work, Terry and Maureen!
 - . ACRL/OR co-sponsored the preconference session at OLA/WLA on improving job performance. 36 librarians from various types of libraries attended [see summary of this session following the Board Highlights]. Without the funding and support of Paul Gregorio and CLEP-O (Continuing Library Education Project of Oregon), this session could not have been offered at such a reduced price. Thanks also to Paul and CLEP-O!
- 3. ACRL/OR also co-sponsored the BNA Reception held on April 22.
- 4. As noted on the cover of this Newsletter, <u>Nancy Powell</u> announced her resignation as Chapter President. <u>Terry Soohoo</u>, Vice-President/President-Elect will carry on as President for the remainder of Nancy's term. Best wishes, Nancy, and ACRL thanks you for your enthusiasm and leadership in the past year.

- 5. A <u>Nominating Committee</u> of three people has been appointed to create a new slate of officers for the 1987-88 ACRL Advisory Board. <u>Alex Toth</u> chairs. A mail-in ballot will be distributed later this summer. [For additional details, see p.2 of this issue of the Newsletter.]
- 6. Plans for the <u>ACRL/Oregon and Washington Chapters Joint Conference</u> are underway. Terry Soohoo is coordinating the Chapter's efforts with the ACRL/ Washington Chapter's President, Dale Burke. See the cover of this Newsletter for further information regarding the fall conference.
- 7. Plans are also being made for ACRL's participation in the next OLA Conference in Spring, 1988. <u>Isabel Stirling</u>, University of Oregon Science Librarian, has volunteered to be ACRL's representative on the conference program planning committee. One suggestion made was to request that there be an academic librarians' LUNCH meeting instead of a breakfast meeting in order to draw more people. In addition, ACRL/OR has applied to sponsor another continuing education course as a preconference to the OLA Conference in 1988. The title of this one is "Public Service under Pressure." <u>Leslie Wykoff</u>, from Oregon Health Sciences University Library, will coordinate this effort.
- 8. The Board recommended that one way to get greater recognition for college and academic library concerns across the state would be to become more involved in committees of other organizations, such as the Oregon Library Association. Included in this Newsletter, you will find a list of <u>OLA</u> <u>committees and their chairs</u>. If you are an OLA member, consider actively participating on one of these committees and bringing academic/college library issues to the attention of OLA.
- 9. The <u>Continuing Library Education Project-Oregon</u> (CLEP-O), coordinated by Paul Gregorio at PSU, needs your ongoing support. Letters of support, addressed to Wes Doak at the State Library and to your legislators, should stress the ongoing need for high quality continuing education opportunities in Oregon. One way to do this is to have CLEP-O placed as a regular part of the budget for the State Library. In your letters, it would also be helpful to note particular workshops offered through CLEP-O which you found particularly enjoyable, informative, useful, and/or additional ones you would like to see offered in the future.
- 10. Funding for the <u>Pacific Northwest Conspectus Database Project</u> has been extended for twenty-six more months. One-half of the funding is provided by the Fred Meyer Charitable Trust and one-half by the State Library. A systematic statewide plan for collection management training and coordinated collection development across the state is needed. Send you concerns about statewide collection management issues to <u>Sue Burkholder</u>, Library Director of SOSC Library and the new Oregon representative to the PNW Conspectus Database Project.
- 11. This past spring, all ACRL/OR Chapter members received a copy of a joint <u>newsletter</u> of OLA, the Oregon Educational Media Association, Special Libraries Association, and ACRL. This cooperative project was an effort to determine the feasability of producing a regular, combined newsletter under the auspices of the Oregon Coalition for Libraries. The Board discussed the value of an ongoing combined newsletter, and is in favor of retaining our own newsletter at present. However, the Board also feels that a joint newsletter

11. once a year (before the OLA Conference) is a good idea. In the Board's opinion, this newsletter should come out in March and should include the same type of material covered in the demonstration issue. If you have comments, criticisms, etc., of the combined newsletter, please send them to ACRL/OR Chapter Newsletter Editor.

CE COURSE WELL-RECEIVED

"Improving Job Performance: Strategies for Supervisors," a continuing education course offered by ACRL National and sponsored by ACRL/OR, was presented as a preconference to OLA on April 22. Thirty-six people attended the day-long presentation.

LEA WELLS was the workshop leader who took class members through various exercises designed to enhance their abilities to motivate staff. Some of the ideas she stressed for establishing a climate for motivation were

shared decision-making
brainstorming
offering praise (especially in public)
sharing praise throughout the ranks
orienting new staff properly and thoroughly
clearly stating expectations and the consequences of not
 meeting them
individualizing rewards
meeting training needs

The course was funded by ACRL/OR, CLEP-0, and a grant from ACRL National. This funding allowed us to offer the course for only \$30. per person. The same course is on the schedule for ALA in June, offered at a cost of \$95. for members and \$135. for non-members.

In 1988, the Oregon Chapter will offer another ACRL CE course, "Public Service under Pressure," as a preconference to the OLA Conference. Keep this in mind when you plan your activities for next year.

Beginning August 12 (Wed.), a preconference on "Creative Conflict Management" will be presented by Peter and Susan Glase of Glaser & Associates, Eugene. On Thursday, Ken Kesey will give the keynote address and later that day, conduct

a workshop on intellectual freedom. Other workshops listed in the preliminary schedule include topics such as cooperative collection development, telecommunications/online reference, CD-ROM's, business reference, management techniques, preservation, and public relations/lobbying.

SLA WORKSHOP PLANNED

The Oregon-Washington chapters of the Special Libraries Association are cosponsoring a workshop on <u>Saturday</u>, <u>September 19</u>, 9:00-4:30, at Portland State University. The topic is HANFORD---ISSUES AND INFORMATION: NUCLEAR WASTE DISPOSAL IN THE NORTHWEST. All librarians and interested citizens are invited to attend this workshop on a topic which affects us all. The morning session will be devoted to overviews of the various issues and the afternoon session will highlight special collections and important documents. In preparation for planning this workshop, three members of the planning committee visited the Hanford Nuclear Reservation. This promises to be a "hot" workshop, so mark your calendars NOW!!

CLEP-O FUNDED BY LSCA

The Continuing Library Education Project-Oregon has been chosen for funding by LSCA grant money for another year. The budget was approved in the amount of \$40,000. per year. This is a reduction from last year, and the difference is expected to be made up by charging for workshops and continuing education classes which were formerly offered free.

An attempt was made to include funding for this project in the Oregon State Library's budget for the 1987/89 biennium, but the money was cut in the Governor's proposed budget.

Library and Media Groups of Oregon (LAMGO) originally wrote the grant request for this project to support a demonstration project for library continuing education. LAMGO now supports the position that funding should be provided from new state General Fund monies, not from LSCA or by shifting monies from other already-existing library programs.

During the last fiscal year, 893 staff members from libraries all over the state attended the 30 workshops sponsored by the Project, under the direction of Paul Gregorio.

Continuance of the grant will be requested again this fall, but the objective of LAMGO is to have this project placed in the regular budget of the State Library for the 1989/91 biennium. Support from legislators will be vital to this effort. Getting the project on the OLA and OEMA legislative priority list is a first step toward state funding. Contact your legislators and library organizations to support continuing education in Oregon.

MLS MAY RETURN TO OREGON

CLARION UNIVERSITY of Pennsylvania may offer a three-year program leading to an MLS degreee through the Division of Continuing Education at Portland State University. PSU has been working with Sarah Long, Library Director of Multnomah County, to determine if an ALA-accredited program could be attracted to Oregon. Clarion is still considering the plan. They have offered a similar program in Maine, and have been asked to return there. According to their spokesperson, their choice is between Portland, Oregon, and Portland, Maine.

Dr. Ruth Person, Dean of the College of Library Science, and Dr. Frank Sessions, Dean of the Colleges of Graduate Studies and Continuing Education, visited Portland State University on May 11 for meetings to discuss the plan. The course of study would require 36 semester hours, 18 of which would be required classes offered at PSU, 6 of which would have to be transfer courses from another graduate department outside the library area, and 12 of which would be taken in residence at Clarion during summer sessions. Classes in Portland would meet only on weekends, to accommodate people who during the week.

The Clarion representatives indicated that they will make a decision by next fall as to whether they would be willing to offer the program in Oregon.

CERTIFICATE PROGRAM IN LIBRARY AUTOMATION

A three-quarter professional development sequence will be offered in Seattle at the University of Washington which will lead to a certificate in library automation. Beginning Autumn Quarter, 1987, the program will include courses as follows:

NEWS FROM AROUND THE STATE

The OREGON INTELLECTUAL FREEDOM CLEARINGHOUSE has been established at the State Library in Salem to collect information about challenges to intellectual freedom in all types of libraries. This central clearinghouse will provide materials on intellectual freedom, will assist librarians in developing policies and procedures to protect intellectual freedom, and will cooperate with other organizations concerned with intellectual freedom issues. Academic

and college libraries, as well as public and special libraries, will receive standardized forms ("Reconsideration Report Forms") to be used to inform the Clearinghouse of incidents where materials have been challenged, of what was done in response to a request to remove materials, and what decisions were made. These forms will be distributed in September, 1987. The Clearinghouse will not only help you determine if an item has been challenged elsewhere in the state, but also maintain a file of reviews of challenged items. Coordinator and contact person for this project is MARY GINNANE, Rural and Small Library Development Consultant, Oregon State Library.

- The FRED MEYER CHARITABLE TRUST LIRN project recently awarded MARYLHURST COLLEGE'S SHOEN LIBRARY a grant to take advantage of Western Library Network's (WLN's) LaserCat CD-ROM product. Out of twenty-three libraries which applied, only 8 awards were made. Congratulations to the staff at Shoen!
- LSCA GRANTS were awarded to the following projects for the amounts indicated: LEWIS & CLARK COLLEGE, for "Writers at Home in Oregon," \$61,200. LINN-BENTON COMMUNITY COLLEGE, for "Consumer Health Information Project," \$36,000. PSU, for "Cooperative Video Acquisition," \$35,000. PSU/Gregorio, for "Continuing Library Education Project-Oregon," \$40,000. Congratulations to these libraries!
- DR. MARGARET E. CHISHOLM, Director of the Graduate School of Library and Information Science, University of Washington, and incoming President of ALA, was the speaker at the Third Annual OSU/UO Continuing Education/Joint Library Meeting, held on May 15, on the OSU campus. Her topic was the future of librarianship.

UNITED KINGDOM FULLBRIGHT AWARD

The United States-United Kingdom Educational Commission in London has announced the opening of the 1988-89 competition for the FULLBRIGHT PROFESSIONAL LIBRARIAN AWARD IN THE UNITED KINGDOM. One award is available for an American librarian to pursue a work attachment at a university library, major research library, or national library in the United Kingdom.

PURPOSE: To promote the exchange of ideas between library staff in the U.S. and U.K. and to enable participants to acquire practical knowledge and experience of library work in a different cultural setting.

<u>Qualifications:</u> U.S. citizenship; must hold a full-time library post as a librarian, library administrator, or archivist at a 4-year college or university, or a major research library outside of higher education; a minimum of 5 years continuous professional experience. A Master of Library Science degree is preferable, though extensive service may be substituted for the degree.

Candidates are expected to be on approved leave of absence with full or partial compensation from their institution. Fullbright provides a modest fixed sum grant to cover travel and settling in expenses and incidentals.

Each applicant is responsible for arranging affiliation with one of the participating libraries. Affiliations are for the purpose of <u>practical work experience</u>. (Proposals of an academic or research-oriented nature are not appropriate for this professional award.)

<u>Duration/deadlines</u>: The award is for a MINIMUM period of three months. The grant period may begin any time after September 1, 1988, and may be up to twelve months. All applications, including references and evidence of institutional affiliation, in the United Kingdom, must be received <u>before September 15, 1987</u>.
